Dear Sir,

I refer to your facsimile of 6 June. I advise you that the only meal I have ever attended with lawyers from Keddie's firm was a lunch at the conclusion of the cases in Singapore. That lunch was attended by all lawyers involved in the cases including the lawyers for the defendant, not just lawyers from Keddie's firm. I did open the Keddie's office at Liverpool as reported in the newspaper.

You are entitled to complain to the Legal Services Commissioner if you feel aggrieved by the conduct of your lawyers and I expect your complaint will be fully investigated.

Dear Judge Blanch,

My name is Hong Mei Liu. My solicitors were Keddies. I was a passenger in a tour bus, when it had an accident and I was seriously injured. You were meant to hear my personal injury claim in Hong Kong. The case was settled and the settlement documents were handed up to you. I was warned by friends that Keddies would cheat me, and that the Australian legal system is there to help lawyers cheat people out of their money.

My friend was cheated by Keddies too, and I should have listened to him. It took him almost a year to be given back \$100,000.00. Why did my case have to come to Hong Kong?? I can return to Australia anytime. My daughter is studying in Australia, and I have been to Australia many times.

I was never told the full amount the insurance company was settling my case for. It is not until now that I am told that my claim settled for \$385,000.00. Keddies never told me that the matter settled for this amount. This amount isn't in any document that I received or signed. The terms of settlement that I signed simply said "\$120,000 plus costs". From this money I was only to receive \$120,000.00, but Keddies made a mistake and gave me \$130,000.00 and said that this extra \$10,000.00 was for being co-operative.

Keddies are a bunch of thieves. I have been asking and asking for a bill, but have been told that Keddies have not charged me anything and therefore I do not have to be given a bill.

I don't know the difference between solicitor client costs and party party costs... they tried to explain it to me, but it doesn't make sense. What I do know is that Keddies have conspired with the insurance solicitors to disguise solicitor client costs as party party costs. I have asked solicitors, the Supreme Court Registrar, barristers and heads of insurance companies; no one has ever heard of party party costs for a claim like mine where liability was accepted being agreed at \$260,762.00. I still have not received a bill. In an effort to hide the true amount my claim settled for, medicare was never and still has not been informed of my settlement. You were to hear other cases in Hong Kong, of friends of mine who were injured in the same accident as me. They too have been cheated. They know that I am complaining.

I am further shocked to now find out that the insurance company had offered \$120,000.00 plus costs as early as 9 March 2007. I was never told this. In allowing my case to be heard in Hong Kong, In failing to properly asking questions of Keddies and the terms of settlement, a person in your position ought to be held responsible, particularly when you have been made explicitly aware that Keddies have been using you, your court and the farce of the Australian legal system to cheat the Chinese people.

Chinese are not backward, and we are not a third world country, and we will not have foreigners come onto our soil to cheat us. We too are linked to the world, and our Judges and Politicians are influential.

I will try your Legal Services Commissioner system to seek justice, but if nothing happens, I will tell the world that almost every matter that you have heard overseas for Keddies have led to people being cheated out of hundreds of thousands of dollars, and that the Chief Judge's court is a monkey room.
